

Outline of International Exchange Subjects Provided by the Osaka University Short-Term Student Exchange Program in Japanese Language and Culture

Students who wish to take International Exchange Subjects provided by the Osaka University Short-Term Student Exchange Program in Japanese Language and Culture (Maple) in the 2025Spring-Summer Semester are required to follow the application procedures described below.

1. Japanese language subjects and lecture/seminar subjects in Japanese

(1) Eligible students: International students of undergraduate and graduate schools (regular students)/exchange students (special auditing students)

(2) Enrollment procedures:

① Students who wish to take the subjects shall take a Placement Test held by Center for Japanese Language and Culture ("CJLC") to assess their individual Japanese proficiency level. However, students who have been evaluated "C1 level" in CJLC within the past one year will be exempted from the test.

Students whose Japanese language level is determined to be "A2 or below" as result of the placement test will not be allowed to take the Japanese language subjects. In addition, the instructor may request that the student stop attending the course if difficulties in class operation are encountered.

② Students who wish to attend the courses shall choose from the subjects based on the level indicated through the Placement Test, fill out the Registration Form (download it from the CJLC website) and shall submit this Form to the CJLC Office (7th floor in Research and Education Hub, 741).

(3) Procedure period:

① Date of placement test: February 18(TUE) to 26(WED), 2025 (*)

② Subject Registration: March 14(FRI) to 21(FRI), 2025

③ Subject registration confirmation: April 7(MON) to 18(FRI), 2025

(*) About the Placement test

The Placement Test will be conducted on the internet.

Placement test application deadline: February 25(TUE), 2025 by 16:00

For more information about the test system, refer to the CJLC website. (Details will be posted in the middle of February.)

(4) Registration restriction: Students cannot take classes of "A2 level". The maximum number of courses that can be taken is 3. Lecture/seminar subjects offered in English may be included in that. You can submit a maximum of five subjects you wish to take in order of preference. In case there are some subjects that you cannot attend in the top three classes you indicated, you will be notified about this by April 4 (FRI).

2. Lecture/Seminar subjects in English

- (1) Eligible students: Students of undergraduate (regular students)/exchange students (special auditing students)
- (2) Enrollment procedures: Students who wish to take the subjects shall choose from the subjects list, fill out the Registration Form (download it from CJLC website) and shall submit this Form to the CJLC Office (7th floor in Research and Education Hub, 741).
- (3) Registration period: The Registration Form shall be submitted from March 14 (FRI) to 21 (FRI), 2025.
- (4) Registration restrictions: The maximum number of courses that can be taken is 3. Japanese language subjects and lecture/seminar subjects in Japanese may be included in that. You can submit a maximum of five subjects you wish to take in order of preference. In case there are some subjects that you cannot attend in the top three classes you indicated, you will be notified about this by April 4 (FRI).

3. Other

Refer to the "List of International Exchange Courses (Maple)" on the CJLC website for the available courses.
